

## Lyons Public Library Board of Trustees Meeting July 16, 2024

The meeting was called to order at 6:30 p.m. in the community room.

**Present:** Chantel Bostic-Bullock, Gary Bennett, Joan Wallis, Leslie Shaw, Marianne Stephan, Scott Bailey, Joe O'Toole, and Matt Owen.

**Motion:** Marianne Stephan moved to accept the June minutes. Scott Bailey seconded. Carried.

**Bills Motion:** Marianne Stephan made a motion to approve the June bills along with an invoice for the steel drum workshop. Chantel Bostic-Bullock seconded. Carried.

**Financial Report**: Sharon Arthur sent this to trustees. Questions about grants received and spent as they appear on the report were answered with the plans to amend the QuickBooks line items to better reflect these transactions.

**Director's Report:** Joe reported a donation of a new paper cutter by an appreciative patron. Also, the circulation desk will be dismantled and its replacement will be lower to accommodate patrons in wheelchairs. He reported that the summer reading program has begun and the theme is "Adventure Begins at the Lyons Public Library." **Official Banks:** Chantelle Bostic- Bullock made a motion to make the Lyons National Bank and Community Bank, NA, the official banks for the Lyons public library. Scott Bailey seconded. Carried.

**Official media outlets**: Marianne Stephan made a motion to make the *Times of Wayne County* and the *Finger Lakes Times* the official media outlets for the Lyons public library. Joan Wallis seconded. Carried.
